- (1) All documents (electronic or otherwise) that you have produced pursuant to a subpoena (including a grand jury subpoena) since January 1, 2005. Produce a copy of the subpoena or discovery request as well.
- (2) All billing statements, retainer agreements, letters of retention, records of payment, or other records reflecting or setting forth an attorney-client relationship between you and any lawyer or law firm who/which practiced in your court.
- (3) Produce copies of all documents reflecting any business or financial transactions between you and any lawyers (including prosecutors such as John Paschall) or law firms who practiced in

your court, or your relatives of the first degree of consanguinity, since January 1, 2005. The term "financial transactions" should be construed to include gifts of any sort, whether cash, personal property, or real property. This demand includes, but is not limited to, business or financial transactions between companies, firms, or partnerships owned by you or the other or law firm, as well as business or financial transactions between you or your respective spouses or relatives of the first degree of consanguinity, as well as any companies, firms, or partnerships owned by them. This request includes, for example, income tax returns that reflect any gifts or income that you received from the aforesaid business or financial relationships.

- (4) Produce copies of all documents reflecting any business relationships between you and any lawyer (including prosecutors such as John Paschall) or law firms who practiced in your court, or your relatives of the first degree of consanguinity, since January 1, 2005. The term "business relationships" should be construed to include any jointly owned enterprises, businesses, corporations, companies, or bank accounts, whether domestic or offshore. This request includes business relationships between companies owned by you (or the other lawyer or law firm), or your relatives of the first degree of consanguinity. This request further includes income tax records that reflect any business relationships described above.
- (5) Produce copies of all communications since January 1, 2005 between you and any lawyer or law firm that practices in your court that were not simultaneously provided to opposing counsel.
- (6) Produce copies of all communications or documents exchanged with the State Commission on Judicial Conduct or any of its officers, agents, appointees, employees or components concerning the case listed above or Richard Keith Moore, Madeline Moore, or Brian Moore.
- (7) Produce copies of all communications or documents exchanged with any third party (*e.g.*, any judge, lawyer, government agency, or government official) concerning the case listed above or Richard Keith Moore, Madeline Moore, or Brian Moore.
- (8) Produce copies of all communications or documents exchanged with any judge, lawyer, government agency, government official or other person concerning Ty Clevenger or *Roy E. Erwin, et al. v. Bryan F. Russ, Jr., et al.*, Case No. W09-CA-127 (W.D. Tex.) and Case No. 4:09-cv-01894 (S.D. Tex.), excepting those communications or documents that were simultaneously provided to Ty Clevenger. This request includes any communications with Judge Walter S. Smith, Jr.
