
Mr. Kinney:

I recently spoke with Troy Bataille, an attorney with the firm of Goldberg Segalla of Hartford, Connecticut. Mr. Bataille stated that you recently contacted him to request a copy of the EPA Peer Audit Review Report for Kilgore College. Mr. Bataille was initially unclear who you were and by what authority you were requesting the information. Mr. Bataille called the College to verify whether or not you are an official of Kilgore College.

Upon learning that you were not an authorized representative of the College, Mr. Bataille correctly advised you that the report had not been prepared and even if it had been completed, the report is an attorney-client privileged document between his firm and the College. Mr. Bataille further stated that you continued to claim a right to obtain a copy of the report and demanded that it be produced. Mr. Bataille felt your efforts were clearly an attempt to circumvent the attorney-client privilege.

Because Kilgore College has an attorney-client relationship with Goldberg Segalla and has clearly asserted the attorney-client privilege, we believe your demand for production and attempts to induce the College's representatives to breach that privilege to be inappropriate. Kilgore College demands that you cease and desist from efforts to induce or persuade its representatives (by deception or otherwise) to release information that, at this point, is privileged. Should you continue, the College reserves all its rights to seek judicial relief along with attorney's fees and costs of court.

When the report is completed and delivered to the College, there are appropriate procedures provided by law by which you can assert your request for information and the College can respond.
