A. PARTIES & DISCOVERY

- Plaintiff, Richard M. Scaman ("Scaman"), alleges that pursuant to Rule 190 of the TEXAS RULES OF CIVIL PROCEDURE, discovery in this cause of action should properly be conducted under a Level 2 Discovery Control Plan.
- Plaintiff, Richard M. Scaman, is an individual who resides in Falls County, Texas and whose social security number ends in 0157.
- Defendant, Larry Pamplin, is an individual and resident of Falls County, Texas, and may be served with citation at his place of residence located at 1403 Lorene Lane, Marlin, Texas 76661.
- Defendant, Trent Pamplin, is an individual and resident of Falls County, Texas, and may be served with citation at his place of residence located at 1084 State Highway 6 South, Reagan, Texas 76680.

 Defendant, Alan Ray Steen, ("Steen") is an individual who resides in Williamson County, Texas and may be served with citation at his place of residence 350 County Road 167, Georgetown, Texas 78626-2268.

B. VENUE & JURISDICTION

- 1. This Court has personal jurisdiction over the Defendants because they are residents of Falls County, Texas, or Travis County, Texas and all or a substantial part of the events that give rise to this litigation occurred in Falls County, Texas. The Court has subject matter jurisdiction over this controversy because the damages sought by Plaintiff are within the jurisdictional limits of the Court.
- Venue is proper in Falls County, Texas pursuant to Chapter 15 of the TEXAS
 CIVIL PRACTICE AND REMEDIES CODE because all or a substantial part of the events and omissions giving rise to this claim occurred in Falls County, Texas.

C. BACKGROUND OF THE PARTIES

1. Richard M. Scaman.

1

Scaman studied Criminal Justice at Columbia College in Ft. Worth. He holds a Master Peace Officer's License from the Texas Commission on Law Enforcement Officer Standards and Education. Scaman has been employed with the Texas Alcoholic Beverage Commission ("TABC") since 2005. Not only was he an employee, he was an employee whose accomplishments were recognized by the TABC on a number of occasions. For instance, in 2008 he was nominated and awarded the Allan Shiver Award for Excellence. According to the Agency, this award is given to four TABC employees per year and recognizes "outstanding performance and accomplishment of agency employees." In 2008 the commission "accepted nominations in four categories using the agency's four cornerstones. The cornerstones are Courtesy, Service, Integrity and Accountability." Scaman was awarded the 2008 award for Integrity. (Exhibit "1") In fact the award brochure provided at the award ceremony noted that

Scaman "demonstrates integrity in both his professional and personal life." (Exhibit "1") Steen himself made the announcement in a July 27, 2009 email that was sent to all employees of the TABC. (Exhibit "2") Scaman was also recognized for his work in the community. He regularly made presentations to children in his area on the dangers of underage drinking and its consequences. (Exhibit "3") When disaster struck Scaman was there to assist in any way possible for those who had their lives disrupted. (Exhibit "4") In fact, he was appointed to the TABC Special Response Team after being nominated by his supervisor and confirmed by his Captain. He was praised by his supervisor for making "our office run at its best." (Exhibit "5") As late as August 19, 2011, his supervisor wrote, "I appreciate the fact that you stepped up to the plate and become [sic] an invaluable part of the southwestern area of our team." (Exhibit "6") He received a confidential survey response from a Licensee who wrote, "our agent, Ricky Scaman, is very responsive and conscientious. He explains the regs & follows up to ensure we have the info we need." (Exhibit "7") Because of this survey response, Scaman received a personal note from Rod Veneer, the Assistant Chief of Enforcement, telling him "I think this says a lot about you & how you conduct your business every day! Thanks Rod." (Exhibit "8") Scaman was a breath of fresh air given the current reputation of the TABC and the Public Relations nightmares the agency has had in recent years. Even the Defendant, Steen, recognized Ricky's accomplishments and made it a point to send him a personal note on his birthday every August the latest being in August 2011. (Exhibit "9") In his latest Personnel Evaluation Form he was given high marks by his supervisor. (Exhibit "10") Those high marks include several areas such as record keeping, where his supervisor described his reports as "detailed and accurate." (Exhibit "10") This section went further to state that during check rides Scaman has demonstrated that he understands the Agency's mission, vision, principles, cornerstones, and philosophies. (Exhibit "10") Finally this Personnel Evaluation mentions Agent Scaman's involvement in the deportation of an illegal alien, Surjit "Gill" Singh, who was suspected of being involved in a foreign money laundering

scheme in Falls County, Texas. This was cited as demonstrating "the cooperative effort that Agent Scaman implements in working with various other agencies." (Exhibit "10") Scaman was up until September 2011 a model TABC officer who had aspirations of running for Sheriff of Falls County, Texas in the November, 2012 elections.

2. Larry Pamplin

Larry Pamplin is a former Falls County Sheriff who stood before the 33rd Judicial District Court in Burnet County on February 13, 1998 and stated in open court that he was not contesting the 3rd Degree Felony charges the State of Texas had brought against him. This crime involved alleged pocketing of over \$23,574 in fake expenses. Pamplin was given deferred adjudication and ordered to pay \$15,000 in restitution, surrender his certification as a peace officer and never attempt to hold any public office in Falls County, Texas. (Exhibit "11") The court specifically stated that it had heard all the evidence and "finds that the evidence substantiates the Defendant's guilt." (Exhibit "11") A man who had used his badge and position to finger print thousands of people in his twenty year tenure as Sheriff of Falls County himself placed his fingerprint and signature on the judgment containing this language. (Exhibit "11")

3. Trent Pamplin

1

Trent Pamplin is the brother of Larry Pamplin who has been arrested convicted of Driving While Intoxicated. Because of this he had to give up his Peace Officers' License for ten years. He and Larry are the sons of the former Sheriff of Falls County, Texas, Brady Pamplin. Trent thought about running for Sheriff himself in 2012 but realized that he had no support for this position. Trent Pamplin previously worked with Defendant, Steen when Steen was the administrator of the Texas Youth Commission lockup in Falls County, Texas. According to Steen, Trent Pamplin was fired from that position for sleeping on the job.

4. Alan Steen

Alan Ray Steen has been the Administrator at the TABC since 2003. He owns property in Falls County, Texas. He is the auctioneer at the Falls County Youth Fair yearly. During his years as an auctioneer he has sold livestock belonging to the Pamplin's children and grandchildren. According to him "he has dealt with the Pamplins for many years." During his tenure at the TABC, the TABC has been involved in a number of scandals including car chases, alleged rapes of minors, shootings, violent bar raids and at least one sexual harassment lawsuit. In 2005, with Steen at the helm of the TABC, the Sunset Advisory Commission issued a sharply worded report on the TABC's failure to keep up with the times. The Sunset board concluded that TABC "does not manage its enforcement activities to best protect the public safety," and TABC "does not prioritize its enforcement activities to focus on the most serious public safety issues." One policy initiated under Steen's direction was the SIPS program. It resulted in a woman being arrested for public intoxication in a bar at the hotel where she was staying. Steen admitted SIPS was a failure stating the enforcement division was "doing the same thing in the same old way." Steen himself was the subject of a February 8, 2010 Williamson County, Texas Sheriff's report. According to the report, Irvin King, a repairman who Steen had called out to work on his parents' motor home, told the deputy Steen said "he was going to kick his ass if he did not take his service contract and leave." According to the report this dispute arose because the repairman wanted to be paid for the work he had undertaken. Most recently, on March 27, 2012 the TABC had a meeting of the commission. One item on the agenda was an Executive Session wherein the performance of the Administrator was to be discussed. Within two weeks of that meeting, Steen announced his resignation effective June 1, 2012.

C. The Current Dispute Between the Parties

1

 As the evidence attached reflects, Scaman was until late September 2011 a valued and decorated employee of the TABC. On September 19, 2011, Steen came to the Waco office of TABC and met with Scaman's supervisor. Scaman was then summoned to meet Steen in Marlin later that afternoon. Scaman drove his TABC vehicle at the direction of Steen to Marlin where he was ordered to get into Steen's TABC vehicle. Steen then drove the two around Falls County, Texas for several hours. The ride included a trip over to Steen's property there in Falls County and eventually ended back where they had started. At the beginning of this drive, Steen presented Scaman with an unsigned list of ridiculous and far-fetched allegations against Scaman. Steen told Scaman that this list had been given to Steen personally by Larry Pamplin. As it was unsigned it is not even to be considered a complaint pursuant to Tex. Gov. Code § 614.022. Steen told Scaman that he did not want the TABC involved in this this type of political mudslinging and that Scaman should not run for Sheriff of Falls County, Texas. Scaman was adamant that this was his dream and stated respectfully he was going to run for Sheriff. The meeting ended with Steen telling Scaman that his decision to run for Sheriff could have a direct effect on his family. It should be noted that Steen's use of his State issued vehicle to go look at his property is a violation of TABC policy that can result in termination.

2. Scaman left that meeting with an ominous feeling. Was he being threatened for invoking his First Amendment Constitutional right to seek public office? Surely not! It seemed odd to him that a non-supervisory agent would have been summoned to meet personally with Steen the Administrator of the TABC. Steen later verified this meeting in a recorded telephone conversation and a recorded conference that was held at TABC headquarters in Steen's office. Based upon what next occurred it was apparent that Steen is involving the TABC in a political controversy. By doing so Steen has violated Section 39.03 of the Texas Penal Code.

3. Scaman learned the next day that he was going to be punished for running for Sheriff of Falls County. On September 20, 2011 Sergeant Kuykendoll, Scaman's supervisor, informed him that he had received word from Headquarters that he could no longer be employed by the Falls County Sheriff's Office as a Deputy Sheriff because his Off-Duty Employment request previously approved had not been approved. This seemed odd to Scaman. When he asked for an explanation, he was given no explanation. This made no sense to Scaman as he had been working there for quite some time. Rather than being disruptive, Scaman put in another Off Duty Employment request for Lorena Police Department. (Exhibit "12") Scaman's request was left pending for over six months with no action. The TABC, at Steen's direction, failed to follow its own policies when dealing with the revocation of the Off Duty Employment request for Falls County Sheriff's office and the non-approval of the Off Duty Employment request for Lorena Police Department. (Exhibit "13")

- 4. Steen's injurious activity and attempts to thwart Scaman's run for Sheriff did not stop there. On October 21, 2011, Scaman's supervisor, Victor Kuykendoll, called Scaman into his office. Kuykendoll alleged that Scaman had submitted DAR reports that were incorrect and that he had not undertaken several inspections he set forth on his DAR reports for September 2, 2011. Scaman explained that he had in fact done the inspections but that he needed to see the documentation of those inspections, his notes and other documentation, prior to responding to the allegation as he had handled over 160 complaints and inspections since that DAR was completed. Rather than allow him to look at his notes and the inspection reports, Kuykendoll explained that Major Robert Cloud and Lieutenant Gene Anderson were there to terminate Scaman.
- 5. Sure enough, Major Cloud and Lieutenant Anderson were there. Cloud exclaimed, "I am not leaving here today unless you resign or are terminated." This is in total disregard of the Policies, Procedures and Forms governing Employee Miconduct, Complaints & Investigations, Policy Number HR-3.06 that was in effect on the date of this meeting. (Exhibit "14") According to this policy, if an employee is accused of misconduct it should be resolved through an administrative inquiry or formal investigation. (page 1, Exhibit "14") In addition, it is

totally out of compliance with the way that Disciplinary actions are to be handled. (Exhibit "15")

In fact, the TABC policy provides as follows:

TABC:

considers employee discipline a serious action to be undertaken with care, objectivity and full consideration for the rights and interest of the employee and the agency.

administers disciplinary action judiciously to ensure equitable and consistent treatment of all employees

supports a fair, consistent and impartial system of discipline that establishes a set of penalties up to and including termination.

determines the level of discipline on a case-by-case basis that takes into consideration the seriousness of the offense, past conduct, previous disciplinary action for similar offenses, and recurrence of offenses.

(page 1, Exhibit "15")

Contrary to following TABC's policies and procedures, Cloud, without even asking Scaman for an explanation of a simple record keeping item, threatened Scaman with termination in an attempt to get Scaman to resign. When Scaman refused to resign, Cloud told him he was suspended and had Scaman's supervisor begin collecting and inventorying TABC property in Scaman's possession. Then after driving Scaman to his home to get his personal car and other TABC property, Scaman was advised that "a terrible mistake had been made and he was not suspended." One must ask, why was TABC attempting to terminate Scaman at this time? He had been a model employee whose supervisor had said his record keeping was "detailed and accurate." Even Scaman's ex-supervisor Tom Dickson believes the DAR system is difficult to operate. He believes that "there was confusion" on how to allocate time under the DAR System, and the method on how to allocate time was constantly changing. (Exhibit "16") Even after the Cloud encounter, Victor Kuykendoll, Scaman's supervisor, sent an email telling people "do not show daily driving as a "Field Selected/Exterior Surveillance. Divide your drive time between the locations to the actual tasks that caused them." (Exhibit "16") There is only one possible

answer. Because he had disobeyed Steen's request that he not run for Sheriff, he was being targeted for termination in violation of his First Amendment Rights.

6. After realizing that their intimidation tactics would not force Scaman to resign, the management at TABC at the direction of Steen undertook to terminate Scaman under the guise of legitimacy. First they filed a formal complaint against him that included the following items:

for failing to fill out his DAR properly;

for wearing his personal handgun instead of his state issued handgun when the inventory was conducted after he was threatened with termination.

for allegedly lying to his supervisor when initially confronted about the DAR

Scaman responded to each of the allegation and explained that he had been told this was the way to fill out the DAR, that he did have his personal had gun on because he had ordered a holster for the state issued hand gun and that he did not lie to his supervisor. He provided a letter from his prior supervisor confirming this DAR issue was confusing and ever changing. He provided the email from Kuykendoll clarifying how to fill out the DAR. He provided a receipt for his order of his new holster for his state issued hand gun. He denied that he lied to his supervisor. One must ask how Scaman could have lied about the DAR when he was not even given a chance to investigate the allegation before being threatened with termination. Even taking these allegations as true, which they are not, these violations would not rise to the level of termination given Scaman's service to the TABC. Clearly other agents improperly filled out their DAR and received only an email as discipline. Why was Scaman being threatened with termination without even being given a chance to explain? What was TABC to do to terminate Scaman for these minor, trumped up infractions? No. They had to find another reason so they went searching.

- 7. One of the accounts that Scaman had been assigned to in Waco was a bar called "Two Minnies." This is a licensed establishment that is also a topless bar although the dancers wear "pasties" Tom Dickson had assigned this bar to Scaman because the TABC had changed the way it wanted to obtain compliance by establishments. Rather than threaten them with legal action, the TABC wanted to obtain voluntary compliance through education. Scaman had a knack of dealing with troubled locations. One day, upon entering the establishment, he was grabbed by a visiting performer and his picture was taken by the manager. The performer had pasties and the bar was in compliance with TABC regulations. Rather than object to the photograph, in an effort to work with rather than alienate the establishment, Scaman simply took control of the Polaroid photograph. Upon his return to the Waco office the photograph was turned over to his supervisor. He was told at this time not to let this happen again and that was the end of this inquiry. This all occurred in 2008 the year Scaman received the previously mentioned award for integrity.
- 8. Under TABC disciplinary guidelines this should have been the end of this inquiry. However, when Steen and the TABC personnel under Steen realized that Scaman would not resign under pressure a directive was sent out to all agents who had worked with Scaman. One of the agents remembered the photo and that another agent had used his cell phone to take a picture of the Polaroid. Cloud on Steen's direction ordered the agent to produce the photo if it could be located. Unless you know the people in the photograph as produced they are unrecognizable. (Exhibit "18") Steen and the TABC used this photo as the final excuse to terminate Scaman and did so on March 15, 2012. In reality, Scaman was terminated because he wanted to pursue his lifelong dream of being Sheriff of Falls County.

9. During the disciplinary process, Larry and Trent Pamplin, began telling people in Falls County, items that could only have been known if there was a leak at the TABC. For instance, the week before the final disciplinary disposition of the TABC complaints were completed, Larry or Trent Pamplin told Michael Baker that "something bad was going to happen to Scaman this week." Amazingly the Pamplin's were correct. TABC terminated Scaman that week. Shortly after this termination, Trent Pamplin began telling people at the Post office and at a local salon that "he and Larry had Scaman terminated at the TABC." Either Pamplin was lying about this or he and Steen were conspiring together to impede Scaman's First Amendment Right to seek public office and to tortiously interfere with his business relationship with the TABC. Based upon all of the evidence attached, the later appears to be more accurate.

D. CAUSES OF ACTION

1

- Based on the foregoing, Plaintiff brings this suit against the Defendants in their individual capacity on the following grounds:
- 2. Tortious Interference with Scaman's right to seek elected office under the 1st

 Amendment of the United States Constitution. Under the U.S. Constitution Scaman has a right to seek elected office. Steen and the Pamplins conspired together to prevent Scaman from running for Sheriff of Falls County, Texas. Steen and the Pamplins used Steen's position as Administrator at the TABC to retaliate against Scaman for running for Falls County Sheriff. They did this by bringing false and overblown disciplinary charges against Scaman after he disregarded Steen's warnings about running for Sheriff. As a result of this Scaman has suffered damages in excess of the minimum jurisdictional limits of this court.
- TABC had a business relationship as did Scaman and the Falls County Sheriff's Department. Scaman also had a prospective business relationship with the Lorena Police Department. Steen and the Pamplins tortiously interfered with these business relationships or prospective business relationships. As a result of this Scaman has suffered damages in excess of the minimum jurisdictional limits of this court.

4. Slander and Libel. The Pamplins and Steen published information about Scaman that they knew to be false and was slanderous and libelous per se. Scaman has been damaged as a result of these false statements and publications.

WHEREFORE, PREMISES CONSIDERED, Plaintiff, RICHARD M. SCAMAN requests that Defendants, Alan Ray Steen, Larry Pamplin and Trent Pamplin, be cited to appear and answer and that on final hearing hereof the Court enter judgment in favor of Plaintiff and against Defendants, as follows:

- Judgment against Defendants in an amount to be determined by the jury;
- Pre-judgment interest at the highest rate allowed by law;
- 3. Post-judgment interest at the highest rate allowed by law;
- 4. Costs of court; and

All such other and further relief to which Plaintiff may be justly entitled.






