WHEREAS, members of a previous grand jury were contacted at their residences and places of employment and given information regarding an investigation.

WHEREAS, the information was received outside the grand jury process and in violation of the laws of the state of Texas.

WHEREAS, the matter regarding which the prior grand jury was improperly contacted remains under investigation.

The Court **ORDERS** that , pursuant to Article 19.42 of the Code of Criminal Procedure, the name and personal information of each grand juror of the 296th District Court, July Term 2015, collected by the court, court personnel, district clerk, prosecuting attorney, or members of the grand jury or its alternates, are confidential and may not be disclosed by the court, court personnel, district clerk, prosecuting attorney or members of the grand jury or its alternates without prior permission of the Court.

The Court further orders that on a showing of good cause, the above sought information will be disclosed to a party to the proceeding.
