Re: July 13, 2015 P.I.A. request

Dear Mr. Clevenger:

I write concerning your letter dated July 13, 2015. In that correspondence, you make two requests pursuant to the Texas Public Information Act. Your first request reads as follows:

"All correspondence, documents, or records wherein any person or entity asked Judge Chris Oldner or Judge John Roach, Jr. to seal the names of grand jurors. This request includes, but is not limited to, motions, letters, and emails, as well as document drafts.

For example, if any person or entity sent a proposed or draft version of the orders sealing grand juror names, that information should be produced, even if it is just an envelope or sticky note addressed to the judge."

I have attached certain documents for your review. Although these attached documents are arguably not responsive to your request because neither this office nor any member of this office "asked Judge Chris Oldner or Judge John Roach, Jr. to seal the names of grand jurors," in an abundance of caution, I am providing them. Although members of this office helped prepare requested drafts of the orders in question, neither this office nor any member of this office requested any judge to seal the names of grand jurors or otherwise issue and/or sign the orders you reference.

Your second request pursuant to the Texas Public Information Act reads as follows:

"All correspondence, documents, or records (e.g., memoranda) explaining how sending information to a grand juror is a violation of the laws of the [S]tate of Texas."

After a thorough and diligent search, we have no documents responsive to your second request. However, please see Chapters 19 and 20 of Texas Code of Criminal Procedure and Section 1.07 (41) (B) and Chapter 36 of the Texas Penal Code for potential violations of the laws of the State of Texas.

In your letter you reference a May 12, 2015 letter from the Lone Star Project to ADA Gail Leyko and make certain allegations regarding the same. For your general information, any correspondence and/or material received by this office involving any potential allegation regarding Mr. Paxton (in whole or in part) is promptly forwarded intact to both prosecutors pro tem and the Texas Rangers for their independent review and possible presentation to a Collin County grand jury.
