Re: Request to view public records

## To Whom It May Concern:

I write to request documents and records (regardless of type, and including electronic, magnetic, paper, audio recording, video recording, or any other media) pursuant to the New York Freedom of Information Law, Article 6, Public Officers Law. In particular, I seek retrievable information related to former Congressman Anthony Weiner and his laptop. See "NYPD, Prosecutors Probe Claim That Anthony Weiner Sent Explicit Messages To Girl, 15," CBS News New York, <a href="https://www.cbsnews.com/newyork/news/nypd-investigates-anthony-weiner/">https://www.cbsnews.com/newyork/news/nypd-investigates-anthony-weiner/</a>. According to published reports, NYPD detectives found evidence on the laptop that Mr. Weiner and former Secretary of State Hillary Clinton were involved in numerous crimes. I request the opportunity to view the following:

- (1) All evidence of criminal activity by Mr. Weiner <u>and any other persons</u> that exists or existed on Mr. Weiner's laptop. This request includes, for example, evidence of sexual abuse of children or sex trafficking or any of the other crimes named in the *True Pundit* article listed above. As another example, if the laptop contains any evidence that the Clinton Foundation was engaged in money laundering or pay-to-play, then those records should be produced. I do not wish to see any images of children.
- (2) All other evidence (*i.e.*, from places other than the laptop) that Mr. Weiner or any associates (*e.g.*, Bill Clinton or Hillary Clinton) were involved in any form of sex trafficking, sexual abuse of children, or other crimes. If, for example, NYPD detectives gathered evidence relevant to whether Mr. Weiner or any associates engaged in sex trafficking, then such evidence should be produced.
- (3) All records and communications from Mr. Weiner's laptop that reference "pizza."
- (4) All records and communications from Mr. Weiner's laptop that reference Jeffrey Epstein, Ghislaine Maxwell, John Podesta, and/or Tony Podesta.
- (5) All records and communications, regardless of source, about Mr. Weiner or his associates traveling to the U.S. Virgin Islands or the Bahamas. If, for example, the NYPD obtained phone records reflecting travel to the Virgin Islands by Mr. Weiner, Bill Clinton, Hillary Clinton, or members of Congress, then those records should be produced.
- (6) All travel records and itineraries on the laptop, regardless of who was doing the traveling.
- (7) All investigative reports, summaries, evidence logs, and email communications regarding Mr. Weiner or any of the individuals who appear in Mr. Weiner's laptop. The term "email communications," as used in this paragraph, does not refer to emails on Mr. Weiner's laptop. Instead, that term refers to emails sent or received by your respective offices or agencies about Mr. Weiner, his laptop, or his affiliates. If, for example, NYPD detectives exchanged emails with FBI agents regarding Mr. Weiner or his laptop, then those emails should be produced.

- (8) All evidence of extortion, bribery, or blackmail (whether attempted or actual) regarding Anthony Weiner or any of the individuals whose names were found on the laptop. If, for example, there is evidence that Mr. Weiner or Mrs. Clinton was blackmailed or blackmailed others, then that information should be produced.
- (9) All evidence obtained during the Weiner investigation that reflects whether public officials were being blackmailed or extorted because of their sexual activities.
- (10) All documents, emails or other communications wherein investigators or prosecutors complained about or alleged (1) interference in their investigation of Mr. Weiner and/or his affiliates (e.g., Mrs. Clinton); or (2) any decision not to prosecute all potential charges against Mr. Winer and/or any of his affiliates, such as Mrs. Clinton.
- (11) All emails and other communications reflecting communications with federal officials, including officials at the Department of Justice and Federal Bureau of Investigation, regarding Mr. Weiner, his affiliates, or his laptop.
- (12) All records or communications in your respective offices that discuss or reflect an attempt to intimidate any investigator or prosecutor who worked on the Weiner investigation.
- (13) According to a report from the Inspector General of the U.S. Department of Justice, FBI agents discovered approximately 141,000 emails to or from Hillary Clinton on Mr. Weiner's laptop. See "A Review of Various Actions by the Federal Bureau of Investigation and Department of Justice in Advance of the 2016 Election," published June 14, 2018, <a href="https://www.justice.gov/file/1071991/download">https://www.justice.gov/file/1071991/download</a>. I wish to see those emails.
- (14) If any of the foregoing information or things has been deleted, destroyed or transferred elsewhere, then produce all records reflecting that.
